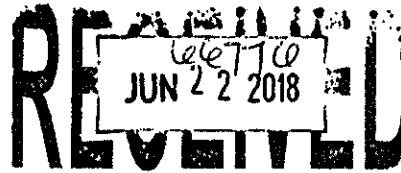

The Overseas Workers Welfare Administration-Cordillera Administrative Region is implementing college scholarship program for children or dependents of Overseas Filipino Workers (OFWs). We are now accepting applications for SY 2018-2019 for the following programs for qualified dependents of OFWs with active OWWA membership for financial assistance of Php60,000.00 per SY to wit:

1. Education for Development Scholarship Program (EDSP) for qualified dependent of active OWWA member who shall enroll or is currently enrolled in any four-year or five-year baccalaureate course in any college or university;
2. Congressional Migrant Workers Scholarship Program (CMWSP) for baccalaureate courses from the priority fields in Science and Technology as identified by the Department of Science and Technology-Science Education Institute (DOST-SEI)

The eligibility requirements for the above Scholarship Programs are as follows:

EDSP	CMWSP
1. Be a child of OFW or a dependent (brother or sister) of an unmarried OFW who is an active OWWA member	Be a child of OFW whose annual gross annual income is not more than US\$6,780.00
2. Not more than 21 year-old graduating high school student or who has graduated but never enrolled to college or associate courses or for those <b>already enrolled in 2<sup>nd</sup> to 5<sup>th</sup> year</b> in college, they should not be more than 30 years old, single, and with <b>GWA of 85%</b>	Not more than 21 year-old graduating high school student or who has graduated but never enrolled to college or associate courses
3. A Filipino citizen with good health and of good moral character	A Filipino citizen with good health and of good moral character
4. Not a recipient of any scholarship award from any government or private institution	Not a recipient of any scholarship award from any government or private institution
5. Has passed the qualifying examination for OWWA EDSP scholarship to be conducted nationwide by DOST tentatively on October 2018. No qualifying examination for those already enrolled in college but their GWA should be 85% or above.	Has passed the qualifying examination for OWWA CMWSP scholarship to be conducted nationwide by DOST tentatively on October 2018.
